## Community Habilitation

Community Habilitation is a service that assists individuals who either live at home with a loved one or independently in the community to maintain or develop the highest level of independence possible for them. Individuals work on goals to build independent living skills in the following areas: personal hygiene, self-care (eating, grooming, etc.), general household chores, mobility training, personal health care, financial management, appropriate social skills, and life safety. Weekly schedules are established by the individual and services can be provided any day of the week.

Community Hab R is a similar service to Community Habilitation, however it is provided for those still living in residential settings with a desire to move out into the community. The service must be provided on weekdays and begin prior to 3pm.

## Certified Day Habilitation

Day Habilitation services are habilitation services that may be provided to an individual regardless of his or her living environment, and regularly take place in a non-residential setting, separate from the individual's private residence or other home. Day Habilitation services can assist individuals to acquire, retain or improve their self-help, socialization and adaptive skills, including communication, travel and other areas in adult education. Activities and environments are designed to foster the development of skills and appropriate behavior, greater independence, community inclusion, relationship building, self-advocacy and informed choice. Additionally, individuals accessing day habilitation often contribute to their communities through volunteer work

Certified Day Habilitation is a site based program that operates Monday through Friday between 9am-3pm. There are three sites, Abbott Rd (south towns), Genesee St (Buffalo) and Humphrey Street (North Tonawanda).

**Community Based Day Habilitation**

Community Based Day Habilitation is a community based program that fosters both community inclusion and community integration.

Believe to Achieve is a community based program that operates Monday through Friday, between 9am-3pm. Services are provided in small groups and typical central to Buffalo and its immediate surrounding suburbs. Groups often participate in volunteer activities. Services are person centered as the group, with the support of a DSP create the calendar of events for the month.

IRE is a community based program for those that are retired. Program operates Monday through Friday, 9am-3pm. There are 3 community sites, Tosh Collins (Lackawanna), Salvation Army (Buffalo) and Humphrey (North Tonawanda) On occasion, groups go out and enjoy community activities based on peoples interests, while other times the retirees can enjoy group activities at the community center along with all center events.

Supplemental Group Day Hab is a community based program that runs on evenings and weekends. SGDH groups are larger and service surround social capital building. Many activities are scheduled on a routine basis; activities range from bowling to movies to self-advocacy group.

Believe to Achieve Teens is a community based program that runs during the evenings. This group focuses on adolescent growth; i.e.: money management, social capital, community exploration.

**Respite Services**

Our Respite Services offer planned short-term and time-limited opportunities for families and care providers to have some personal time. These programs provide recreational and social experiences in a safe environment. Eligibility for respite services includes: needs to be enrolled in the Home and Community Based Waiver (HCBS), between the ages of 5 and 21 years old, and have a developmental disability.

Our after-school program is open to school-age children with developmental disabilities and operates Monday through Friday from 2 to 6 p.m. at various locations.

We also provide Saturday Respite for children ages 5 and older. Saturday Respite operates on designated Saturdays between 9 a.m. and 5 p.m.

Children's Overnight Respite is offered at the Children's Guild Foundation Mildred M. Seegler Respite House in Tonawanda.

**Family Support Services (FSS)  
Behavior Intervention Program**

This program provides in-home behavioral and parenting support services to people residing with their families. This includes adults, children and parents with developmental disabilities. Collaborative in-home evaluations are completed to assess the behaviors present and develop a family-centered plan. The BIS and Technician partner with the family to train and work on a plan to provide these supports in a familiar setting where the person feels secure. The goal is to implement successful techniques that manage or eliminate behaviors completely.

**Intensive Behavioral Services (IBS)**

Intensive Behavioral Services (IBS) provides behavioral support to those residing in non-certified settings or Family Care Homes, who are waiver enrolled and who present with challenging behaviors. Prior authorization from the local DDRO is required before a referral can be made. Collaborative in-home evaluations are completed to assess the behaviors present, conduct a Functional Behavior Assessment and develop a Behavior Support Plan. The service is time-limited for a period of up to 180 calendar days. The services include up to 25 hours of in-home service after the plan has been developed.

**Family Supports Services (FSS)  
In-Home**

The habilitation Services Department will provide home and community based skills or self-development training services to children and adults who are exhibiting deficits in independent living care skills. The focus is to increase or maintain the skills of the person, thereby reducing reliance on family caregivers. Skills development training will be provided individually or in a group setting in the person's home or community location. This can include continuing education to teach or develop skills of the individual served. Training will include budgeting, financial management, cooking, nutrition, shopping, housekeeping, person hygiene, laundry, mobility training, parenting skills and leisure skills development and any other skill needed by the person referred to the program.

Pathway to Employment is a person-centered employment planning and support service that provides assistance for individuals to obtain, maintain or advance in competitive employment or self-employment. This service offers an individualized planning process that helps individuals identify a career or vocational direction. Pathway to Employment also provides instruction and training in job readiness skills and develops a plan for achieving competitive, integrated employment at or above the New York State minimum wage. Within 12 months the outcome of this service is documentation of the participant's stated career objective; a detailed career plan used to guide individual employment supports; and preparation for supported employment services.

Community Prevocational Services address the individual's vocational interests. The program assists individuals who are interested in joining "the world of work" but whose skills are such that they may not expect to obtain competitive employment within the next year. **ACCES-VR Intensive Services** provides vocational counseling and rehabilitation services that result in successful employment outcomes for individuals with disabilities and their employers.

**ACCES-VR Youth Employment Services (YES)** - include a range of services to assist youth with their transition to the world of work. YES is delivered with a focus on the unique concerns and issues of youth and are related to preparing for employment, developing employment related soft skills and obtaining work experience. YES may combine individual services in a meaningful way to enhance job readiness, provide a work experience, and provide coaching supports, etc.

**ACCES-VR Extended Services**-This program provides follow along SEMP services to employed individuals who are not Medicaid eligible. Each agency that provides ACCES-VR services are awarded a certain number of placements for these individuals.

PROMISE is a research project that advances employment and postsecondary education outcomes for 14–16 year old youth who receive Supplemental Security Income. Promise was designed to help students to transition from school to work. Participants for this program are chosen by school officials. Promise focuses developing employment related soft skills and obtaining work experience. Promise enhance job readiness, provide a work experience, and provide coaching supports, etc.

**Employment Training Program (ETP)**

Employment Training Program (ETP) offers individuals an opportunity to work in an internship that will lead to permanent employment in a community business. During the internship, wages will be paid by through ETP while the individual learns the skills needed for the job. ETP participants also attend job readiness classes that present topics such as conflict resolution and how to dress for work. ETP services include increased job development and job coaching as well as assistance with other employability skills.

HCBS Waiver Supported Employment– HCBS Wavier SEMP provides the supports individuals need to obtain and maintain paid competitive jobs in the community. Individuals with developmental disabilities will typically transition to SEMP after they have received supported employment services funded by ACCES-VR and require limited job coaching to successfully maintain their employment. Individuals also come to supported employment from program that offer intensive training such as ETP.

Western New York's only Developmental Disability Offender Program dedicated to helping people with developmental disabilities navigate the various stages of the criminal justice system. The DD Offender Program is recognized by the NYS Division of Criminal Justice Services (DCJS) as an Alternative to Incarceration Program. Provides advocacy and assistance throughout the court process and monitors legal obligations while working with Probation, Parole and Courts to establish a plan for success. Completes assessments and case management in order to determine risk related to reducing recidivism.

Preventive Services are provided to families through a contract with the Erie County Department of Social Services (ECDSS). All families served through the Preventive contract are at risk for or have children placed in foster care, and are eligible for mandated Preventive services as determined by ECDSS. Referrals are received from ECDSS and priority will be given to families with complex needs including substance abuse, domestic violence, severe neglect, dual diagnosis (mental health as well as developmental disability), criminal justice involvement, etc. Families served may have a member of the family who has a developmental disability (parent or child) but it is not a requirement.

A Health Home is a care management service model that connects all of a person's health professionals to improve communication so that all of a patient's needs are completely met. This is done primarily through a "Care Manager" who oversees and provides access to all of the services a person needs to make sure they have everything necessary to stay healthy, out of the emergency room, and out of the hospital. Health records are shared among providers so that services are not duplicated or neglected.

Adults or children must have 2 chronic conditions or 1 serious, persistent mental health condition and be eligible for Medicaid.

Chronic conditions include, but are not limited to the following:

- Asthma
- Obesity
- Alcohol or substance use disorder
- Mental health condition
- Hypertension
- Metabolic disease
- Visual Impairment
- ADHD

The Parents and Youth Program provides crisis intervention and/or service coordination like services to individuals and/or their families who are involved or at risk of becoming involved with the Family Court and/or Child Protective Services (CPS). The program also helps them meet additional immediate needs such as: living environments, navigating family court, linkage to court ordered services, transportation to and advocacy during necessary meetings or appointments, parenting support and many other areas. This program also assists with enrollment in HCBS Waiver Services. (both FSS and ECDHS funded)

The Community Living Program will assist individuals and their families who are in need of support services such as: case management, information and referral, financial planning and assistance and transportation to seniors, as well as assistance for school aged people transitioning into adult services. Support also includes locating and maintaining appropriate housing, information and referral to appropriate ancillary service providers, and assistance in applying for benefits and OPWDD Eligibility. Support will also include assistance in linkage to medical providers and with advocacy at medical appointments. Some support may be provided in areas of household management while waiting for traditional habilitation services to begin.

**Assistive Technology:** Adaptive devices are aids, controls, appliances, or supplies - of either a communication or adaptive type - which are necessary to enable a person to increase or maintain his or her ability to live at home and in the community with independence and safety. Assistive Technology includes, but is not limited to: augmentative communication aids and devices, adaptive aids and devices, and vehicle modifications.

**Environmental Modifications (E-Mods)** are physical adaptations to the home that can increase or maintain the individual's ability to live at home with independence. Environmental modifications include, but are not limited to, ramps, lifts, hand rails, bathroom modifications (such as roll-in showers). In addition to these physical types of modifications to the home, E-Mods can include modifications that address the individual's sensory deficits, such as Braille identification systems and strobe light smoke detectors and alarm devices, and modifications that promote a safer environment for individuals with challenging behaviors, including window protection, reinforcement of walls, open-door signal devices and durable wall finishes.

To be eligible for Assistive Technology or Environmental Modification services through OPWDD, the individual must be enrolled in the Home and Community-Based Services Waiver or the CAH Waiver.

Individual Residential Alternatives (IRAs) are houses located throughout the Western New York community which offer a variety of different living options. These homes are designed to integrate residents into the community of their choice and create opportunities for successful living and increased independence. We offer community-style homes that provide residents with their own bedroom and a shared living space, as well as apartment-style home which feature complete apartments for residents.

Our Emergency Residence provides temporary housing to people with developmental disabilities who are in need of a place to live. Each resident receives a private bedroom and shares community space. This location is within walking distance to public transportation. Our team will assist people in gaining the skills necessary to live as independently as they choose. There is a maximum of a 135 day stay, however during that time our team will work with the person and their circle of support to secure permanent housing.

Our Transitional Residence for people with developmental disabilities helps those who are homeless. The unique home offers both a supervised, group-style setting and two supervised apartments. There is a maximum of a two-year stay; during that time our team will work with the person to formulate a person-centered plan based on your needs.

Our Safe House was the first shelter in the nation specifically designed for people with developmental disabilities who are victims of domestic violence, crimes and/or abuse. The Safe House provides confidential shelter to people with developmental disabilities. Our goal is to actively assist them while they transition into a safe and permanent home. Placement is also available for people living in an unsafe or high-risk environment.
